LDRTC HAS A DONATE NOW BUTTON ON THEIR WEBSITE, THUS WELCOMING DONATIONS FROM OTHER ORGANIZATIONS. OTHER RELEVANT FACTORS IN DETERMINING WHETHER LDRTC MEETS THE "FACTS AND CIRCUMSTANCES TEST," IS THAT THE TREASURY REGULATIONS ALSO PROVIDE A LIST OF FACTORS THAT SERVE AS AN INDICATION OF WHETHER AN ORGANIZATION QUALIFIES AS "PUBLICLY SUPPORTED."
